

Negotiable Instruments Act, 1881, Section 20 – Once a person affixes his signature on a sufficiently stamped paper and delivers it to the other, the holder or the holder in due course can fill up the same with any amount covered by the stamp and the person who delivers the stamped instrument is liable to pay the amount covered by the stamp.
